### Introduction

Meva Glass Inc ("Company" or "We") respect your privacy and are committed to protecting it through our compliance with this policy.

This policy applies to information we collect:

- Your search gueries on the Website.

You also may provide information to be published or displayed (hereinafter, "posted") on public areas of the Website, or transmitted to other users of the Website or third parties (collectively, "User Contributions"). Your User Contributions are posted on and transmitted to others at your own risk. Although we limit access to certain pages/you may set certain privacy settings for such information by logging into your account profile, please be aware that no security measures are perfect or impenetrable. Additionally, we cannot control the actions of other users of the Website with whom you may choose to share your User Contributions. Information We Collect Through Automatic Data Collection Technologies
As you navigate through and interact with our Website, we may use automatic
data collection technologies to collect certain information about your equipment,
browsing actions, and patterns, including:

- Details of your visits to our Website, including traffic data, location data, logs, and other communication data and the resources that you access and use on the Website.
- Information about your computer and internet connection, including your IP address, operating system, and browser type.
